A TRACT OF LAND LOCATED IN A PORTION OF SECTION 1, TOWNSHIP 12 SOUTH, RANGE 69 WEST OF THE 6<sup>TH</sup> P.M., AND A PORTION OF THE WEST ONE-HALF (W1/2) OF SECTION 6, TOWNSHIP 12 SOUTH, RANGE 68 WEST OF THE 6<sup>TH</sup> P.M., TELLER COUNTY, COLORADO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTH ONE-QUARTER CORNER OF SAID SECTION 1, AS MONUMENTED BY A 2-1/2" BRASS CAP STAMPED "U.S. GENERAL LAND OFFICE SURVEY 1935", FROM WHICH THE NORTHWEST CORNER OF SAID SECTION 1, AS MONUMENTED BY A 2-1/2" BRASS CAP STAMPED "U.S. GENERAL LAND OFFICE SURVEY 1935", BEARS S89°18'56"W, A DISTANCE OF 2655.21 FEET AND IS THE BASIS OF BEARINGS USED HEREIN;

THENCE N89°18'17"E ALONG THE NORTHERLY LINE OF SAID SECTION 1, A DISTANCE OF 96.50 FEET TO THE POINT OF BEGINNING OF THE TRACT HEREIN DESCRIBED;
