DESCRIPTION:

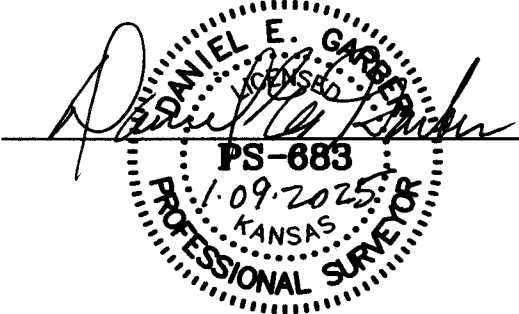
PARCEL 1:
A portion of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian, Reno County, Kansas, more particularly described by Daniel E. Garber, Professional Surveyor #683, on December 27, 2024 as follows:
Commencing at the Northeast corner of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian; Thence with a bearing of South 00°59'03" East (basis of bearings is NAD 83 Kansas South Zone) along the East line of said Northeast Quarter a distance of 535.37 feet for the point of beginning; Thence continuing South 00°59'03" East along the East line of said Northeast Quarter a distance of 707.17 feet; Thence South 89°00'57" West perpendicular to the East line of said Northeast Quarter a distance of 431.18 feet; Thence North 00°59'03" West parallel with the East line of said Northeast Quarter a distance of 707.17 feet; Thence North 89°00'57" East perpendicular to the East line of said Northeast Quarter a distance of 431.18 feet to the point of beginning, containing **7.000 Acres**, and subject to a road right-of-way easement across the East 40.00 feet thereof and any other easements and restrictions of record.

PARCEL 2:
A portion of the North Half of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian, Reno County, Kansas, more particularly described by Daniel E. Garber, Professional Surveyor #683, on December 27, 2024 as follows:
Beginning at the Northeast corner of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian; Thence with a bearing of South 00°59'03" East (basis of bearings is NAD 83 Kansas South Zone) along the East line of said Northeast Quarter a distance of 535.37 feet; Thence South 89°00'57" West perpendicular to the East line of said Northeast Quarter a distance of 431.18 feet; Thence South 00°59'03" East parallel with the East line of said Northeast Quarter a distance of 707.17 feet; Thence North 89°00'57" East perpendicular to the East line of said Northeast Quarter a distance of 431.18 feet to the East line of said Northeast Quarter; Thence South 00°59'03" East along the East line of said Northeast Quarter a distance of 100.00 feet to the Southeast corner of the North Half of said Northeast Quarter; Thence South 88°21'59" West along the South line of the North Half of said Northeast Quarter a distance of 569.64 feet; Thence North 01°38'01" West a distance of 1,340.97 feet to the North line of said Northeast Quarter; Thence North 88°13'15" East along the North line of said Northeast Quarter a distance of 584.86 feet to the point of beginning, containing **10.780 Acres**, and subject to road right-of-way easements across the North 40.00 feet and East 40.00 feet thereof and any other easements and restrictions of record.

PARCEL 3:
A portion of the North Half of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian, Reno County, Kansas, more particularly described by Daniel E. Garber, Professional Surveyor #683, on December 27, 2024 as follows:
Commencing at the Northeast corner of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian; Thence with a bearing of South 88°13'15" West (basis of bearings is NAD 83 Kansas South Zone) along the North line of said Northeast Quarter a distance of 584.86 feet for the point of beginning; Thence South 01°38'01" East a distance of 1,340.97 feet to the South line of the North Half of said Northeast Quarter; Thence South 88°21'59" West along the South line of the North Half of said Northeast Quarter a distance of 2,101.66 feet to the Southwest corner of the North Half of said Northeast Quarter; Thence North 01°12'15" West along the West line of the Northeast Quarter a distance of 1,335.70 feet to the Northwest corner of said Northeast Quarter; Thence North 88°13'15" East along the North line of said Northeast Quarter a distance of 2,091.65 feet to the point of beginning, containing **64.416 Acres**, and subject to a road right-of-way easement across the North 40.00 feet thereof and any other easements and restrictions of record.

PARCEL 4:
The North Half of the South Half of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian, Reno County, Kansas, more particularly described by Daniel E. Garber, Professional Surveyor #683, on December 27, 2024 as follows:
Beginning at the Northeast corner of the South Half of the Northeast Quarter of Section 15, Township 26 South, Range 4 West of the 6th Principal Meridian; Thence with a bearing of South 00°59'03" East (basis of bearings is NAD 83 Kansas South Zone) along the East line of said Northeast Quarter a distance of 671.27 feet to the Southeast corner of the North Half of the South Half of said Northeast Quarter; Thence South 88°26'21" West along the South line of the North Half of the South Half of said Northeast Quarter a distance of 2,668.69 feet to the Southwest corner of the North Half of the South Half of said Northeast Quarter; Thence North 01°12'15" West along the West line of said Northeast Quarter a distance of 667.85 feet to the Northwest corner of the South Half of said Northeast Quarter; Thence North 88°21'59" East along the North line of the South Half of said Northeast Quarter a distance of 2,671.29 feet to the point of beginning, containing **41.039 Acres**, and subject to a road right-of-way easement across the East 40.00 feet thereof and any other easements and restrictions of record.
