

These exemptions are automatically renewed each year unless there is a change in ownership, death of the current applicant or you no longer meet the eligibility requirements. For all exemptions, the property must be in the name of the applicant as of January 1st. Any age-based exemption is as of January 1st. The deadline for applying for all exemptions for the upcoming year is April 1st.
